Committee: FODAC Director, Public Works Superintendent, Town Administrator, Building Inspector, Alderman (Mike Nelson). Mayor Gantte also asked that the Town Attorney be included on the committee.

- Joyce Bussell Library Concerns
 - Opes Dandridge have an emergency system? Does the public know about it? What does is sound like? When is it tested? What is it used for? (VFD member responded that there is an alarm on the downtown fire station)
 - Suggest that a detour sign be placed directing traffic to the library due to road closure for bridge construction. (Public Works Superintendent stated that detour signs to Circle Drive are already in place. Town Administrator also stated this item can be addressed in an upcoming meeting with the bridge contractor and library)
 - o Library landscape has been neglected. Trimming needs to be done around the air conditioner unit and the rose bushes. Plants need to be fertilized. Areas need to be pressure cleaned and molding is coming

off a pillar. Eaves are overflowing. (Gerry Hardy, who recently passed away, used to take care of the landscape. The town was not aware that she had become ill and was no longer caring for the landscape. The Town has since taken over care of the landscape)

- Retain/Replacement of the Appointed Personnel
 - o Town Judge
 - Town Attorney
 - Chief of Police
 - Fire Chief
 - DWMF Superintendent

It came on a motion by Alderman THORNHILL, seconded by Alderman CHAMBERS, to retain all the above mentioned personnel.

On a voice vote, the motion passed unanimously, and was so ordered.

Consideration of a Designated Loading/Unloading Zone on Tinsley Lane

Bill Swann, Subway, requests a designated unloading zone, Wednesday's, 9:00am – 11:00am. Public Works Superintendent Gregg Gann does not agree with a designated unload zone, but recommends that cones be utilized on delivery days. Alderman Kesterson suggests that deliveries continue as present without designated zones in hopes that a delivery can be unloaded within 20-30 minutes with no hassle. Chief of Police suggests that the situation continue to be monitored and if not solved, then will speak directly to person who does not like the delivery truck being unloaded in the area. Chief of Police will try and resolve situation and report back to BMA with further issues as needed to be addressed.

It came on a motion by Alderman THORNHILL, seconded by Alderman KESTERSON, to table this item until the next scheduled work session for further review if needed.

On a voice vote, the motion passed unanimously, and was so ordered.

XII. MISCELLANEOUS

- Town Administrator Melissa Peagler provided information regarding the potential of paying off a tractor versus financing. \$15,900 has currently been budgeted for a tractor purchase. Financing would be a 5 year lease. A straight purchase would save approximately \$5,000.
- Town Administrator also gave an update on the THDA Home Grant for housing rehabilitation. The company that had been chosen to execute the grant has given notice that they will be closing their company. Another company will be selected to move the grant forward. Construction on four homes should begin this fall.
- Alderman Farrar inquired of the possibility to install new street lights (same as those recently installed on the
 west side of Gay St.) along the east side of Gay St. and down Main St. towards Town Hall. Town Administrator
 will meet with Greg Williams of Appalachian Electric before the September work session to get options for
 consideration.
- Chief of Police Carson Williams reported that for the next three days Simpson Construction will be delivering 3 153' steel beams for the new bridge. Route of travel will be from the First Baptist Church down Gay St.

XIII. ADJOURNMENT

It came on a motion by Alderman THORNHILL, seconded by Alderman KESTERSON, that the meeting of August 9, 2016 be adjourned.
